



Road Closure Reminders

Changing construction patterns on High Street causes changes in bus route times and traffic patterns during student pickup and dropoff. Road closures may affect routes far away from High Street as traffic flows onto other streets through town.

Monroe Street, Lockerbie Street, and the section of State Road 42 including White Lick Creek bridge are opened to local traffic and bus traffic. The official state detour will remain in place. SR42 is completely closed from Carter St. to the East side of Indiana St. According to INDOT, the Indiana St. intersection



will be closed for approximately 30 days and the remaining portion of SR42 from Carter St. to Indiana St. will hopefully be completed in late September. Additional information is available on the INDOT West Central Facebook Page.

Back-to-Vaccination Deadline

Students entering kindergarten, 6th grade and 12th grade have additional vaccinations needed. Families are encouraged to contact their family doctor or their school Student Health Services as soon as possible to see what vaccinations are needed. Beginning the process of immunizations is important since any child who needs their Hepatitis A vaccinations will need to have two doses spaced six months apart. Mooresville's deadline for vaccinations is on September 1, 2021.

Indiana Code states a document of immunizations must be provided to the school upon enrollment which shows the child has received at least the minimum number of doses for his/her age.



School Protocols for COVID-19:

Mooresville Schools will follow all guidance from the Morgan County Health Department for the health and safety of school students, staff, and visitors. Coronavirus COVID-19 Protocols 2021-2022 School Year

Please Note: These protocols reflect current guidance from federal, state and local health officials. Should guidance change, school protocols will be updated to reflect current information. 8/12/21

The safety and well-being of our students and staff are of utmost importance. We appreciate everyone's help with the following guidelines for our return to school.

- Masks are recommended for anyone who has not been vaccinated.

 Masks are not required; however, we respect the right of anyone who chooses to wear a mask at school.
- Masks are required on school buses for the duration of CDC mask guidance for public transportation. Masks will be provided to those who do not have them.
- Water bottling filling stations will remain open and water fountains will remain closed. Students will be asked to use water bottles at school.
- Close Contact and Quarantine guidance from IDOH will be followed in accordance with <u>Indiana Code 16-41-2-1</u>. Due to social distancing requirements for early returns, close contact quarantines will be 14 days.
- Assigned seating and increased spacing between students will remain in classrooms, the cafeteria, and other group settings to fulfill contact tracing obligations.
- Increased cleaning and disinfection in all areas will remain in place.
 School air filtration systems meet or exceed all requirements for fresh air circulation.
- If school member or their household member is testing, unvaccinated students or staff should stay home until test results are received
- Unvaccinated students or staff who are close contacts with someone who has COVID-19 must quarantine per health department guidance. No student or staff member will be asked about vaccination status except as part of a close contact situation.
- Home COVID-19 test kits and Rapid Tests will not qualify as an alternate diagnosis or for an early return to school. A PCR test must be done to return to school if there are symptoms.
- Extracurricular activities will resume with the same protocols as school attendance. IHSAA and ISSMA guidance will be followed.

Best Practices

The 2020-21 school year taught us there are many important practices to help keep Pioneers healthy.

Proper hand washing

is the best way to limit the spread of COVID-19. Students will have many opportunities each day to wash their hands and use sanitizer.

Monitoring student health

before school each day is crucial.

Students with a fever or signs
of illness (including but not
limited to: vomiting, diarrhea,
uncontrolled cough, sore throat,
and loss of taste or smell)
should not come to school.

Symptomatic students need a
negative PCR test or alternate
diagnosis to return to school.

Vaccinations

are recommended by the CDC for anyone age 12 or older.

School health clinics

will have separate areas for students with symptoms.

When in doubt,

stay home and contact your school's student health services or the Morgan County Health Department (765-342-6621) for guidance.

Contact Tracing will still be in place in accordance with Indiana Department of Health guidelines.



Close contacts include anyone within 6' of the positive case for 15 minutes or more over the course of a day. There is a 48hour "lookback" for close contacts prior to symptom onset/positive test.



Close contacts who do not show proof of vaccination will be required to quarantine. Vaccinated close contacts who are asymptomatic do not need to quarantine.
